  - Policy 1410 Executive of Closed Sessions

Reflects a recent holding by the Washington State Supreme Court and SHB 1417, which added discussion of information technology security as another purpose for holding an executive session.

- Policy 3115 Homeless Students
- Policy 3116 Students in Foster Care

WSSDA has updated Policy 3115, Homeless Students, and Policy 3116, Students in Foster Care, to reflect changes brought about by SHB 1444, SSB 5241, and SHB 1641, which are all effective July 23, 2017.

• Policy/Procedure 3416 Medications at School

WSSDA has updated Policy and Procedure 3416, Medication at School, due to the passage of the Student Sun Safety Education Act (SSB 5404) during the 2017 legislative session.

• Policy/Procedure 3432 Emergencies

WSSDA has updated Policy and Procedure 3432, Emergencies, to reflect SHB 1279. SHB 1279 revises the list of nine safety-related drills that schools must conduct per year by specifying that schools teach three basic functional drills: shelter-in-place, lockdown, and evacuation.

• Policy/Procedure 4040 Public Access to District Records

Reflects Public Records Administration ESHB 1594, Public Records Requests Costs EHB 1595, and Hikel v City of Lynnwood, Division I (December 27, 2016)

• Policy 5005 Employment and Volunteers: Disclosures, Certification Requirements, Assurances and Approval

The update of the policy pertains to background checks for all staff and volunteers who have regularly scheduled unsupervised access to students, certification requirements of certificated staff, and procedure for reemployment of classified staff.

- Policy/Procedure 6100 Revenues from Local State and Federal Sources

WSSDA has updated Policy and Procedure 6100, Revenues From Local, State and Federal Sources, due to the passage of School District Excess Levies (ESB 5023) as amended by Basic Education Funding HB 2242, during the 2017 legislative session. The update reflects the additional step of reporting planned usage of levy proceeds to OSPI.

• Policy/Procedure 6220 Bid Requirements

Updated to comply with SS B 5301, Responsible Bidder Criteria—Wage Laws Compliance,

• Policy 6905 Site Acquisition

WSSDA has updated Policy 6905, Site Acquisition, to reflect ESHB 1017 and HB 2243

Updated to comply with SB 5049, which was enacted to establish a uniform policy for the fair and equitable treatment of persons displaced because of public works.
